### CIVIL-MILITARY RELATIONS (CMR)

#### WOMEN IN STRATEGIC DEFENSE AND SECURITY DECISION MAKING

This virtual seminar provides an application of Women Peace and Security principles to issues in the regional context. Topics will include: Strategies to Improve Women's Representation, Recruitment and Retention of Women in Defense and Security Institutions, Protection of Civilians, Combating Trafficking in Persons, Gender considerations in Humanitarian Assistance and Disaster Relief, the role of International Humanitarian Law and Human Rights Laws, and how to maximize use of Gender Analysis in support of intelligence, plans, and operations. This offering is designed for international military officers and their civilian equivalents in mid- to senior ranks (O4-O6) who are engaged in issues related to Women Peace and Security initiatives driven by UNSCR 1325, and who are interested in greater inclusion of gender considerations National Defense and Security institutions.

### INTERNATIONAL DEFENSE ACQUISITION RESOURCE MANAGEMENT (IDARM)

#### PRINCIPLES OF DEFENSE ACQUISITION MANAGEMENT

This virtual offering provides a theoretical examination of underlying concepts and fundamentals of defense acquisition management. International best practices are discussed along with challenges associated with implementation. Participants will gain an increased understanding of the important concepts and challenges associated with defense acquisition and logistics decision making. Sample topics include: Defense Acquisition Overview, Principles of Good Budgeting and Resource Management, Life Cycle Cost Management, and Building and Sustaining Accountability in Defense Acquisition Decision Making. This offering is designed for international military officers and their civilian equivalents of grades O4-O6 who are engaged in a broad range of acquisition fields, such as policy development, strategic planning, requirements definition, logistics, program management, procurement and contracting, and budgeting and execution.

## PEACE & SECURITY

### MARITIME SECURITY (MARSEC)

#### BUILDING INSTITUTIONAL CAPACITY IN THE MARITIME SECURITY SECTOR

This virtual offering is designed to assist those individuals and organizations responsible for their nation's maritime security sector. The course will cover various threats to maritime security, from piracy and armed robbery at sea, smuggling and trafficking of drugs, arms and people, to cyber attacks against maritime infrastructure. The course will emphasize the detection and monitoring of suspect vessels in the nation's Exclusive Economic Zone (EEZ), territorial seas and inland waterways, and appropriate responses. It is tailored to meet the needs of operational forces, decision makers at all levels, and regional security organizations. The intended audience is mid- to senior- level military (Navy and Coast Guard O-4 to O-8), or civilian and law enforcement officials from various ministries and government organizations with maritime security responsibilities such as Defense, Interior, Fisheries, and Foreign Affairs.

## PEACEKEEPING AND EXERCISES

### PROTECTION OF CIVILIANS & PEACEKEEPING OPERATIONS SUPPORT

This virtual training offering is a subject-specific train the trainer course conducted by the Institute for Security Governance. This course builds participants' sustainable training skills for protection of civilians subjects in support of United Nations Peacekeeping Operations (UN PKO). This course is ideally suited for junior- to mid- level officers or civilian equivalents. The course is designed to provide a common conceptual understanding of protecting civilians in the context of UN peacekeeping. It explores the range of protection actors, the unique nature of sexual violence in armed conflict, legal rules and authorities that govern actions of peacekeepers, a framework for protection, and the political/institutional consequences of the failure to protect.

## VIRTUAL INSTRUCTION

These activities will be executed on a virtual learning platform, so while there is no travel, participants will need to have access to a computer and an Internet connection for the duration of the event. Each course will include synchronous/"live" virtual instruction for approximately 4-6 hours each day, with some asynchronous course work to be completed outside these hours. Multilateral seminars are conducted in English, unless otherwise indicated. Bilateral virtual courses are available upon request.
